VIRGINIA LOTTERY'S MUSCLE CAR MONEY OFFICIAL SWEEPSTAKES RULES

- A. PURPOSE:** A Sweepstakes (“Sweepstakes”) will be conducted to support the Virginia Lottery’s \$5 “MUSCLE CAR MONEY” scratcher game. Four (4) drawings (“Prize Drawings”) will be conducted with this Sweepstakes. Each drawing will be conducted to award one (1) MUSCLE CAR (“Vehicle Grand Prize”) and three hundred and ninety-four (394) MUSCLE CAR MONEY Merchandise Prize Packages.
- B. SWEEPSTAKES PERIOD:** The Sweepstakes will be conducted beginning on Tuesday, May 11, 2010 and ending Monday, September 27, 2010 (“Sweepstakes Period”). In conjunction with this Sweepstakes, four (4) drawings will take place, one (1) on Tuesday, June 15, 2010, one (1) drawing on Tuesday, July 20, 2010, one (1) on Friday, August 27, 2010 and one (1) on Tuesday, September 28, 2010 to select the winners for this Sweepstakes.
- C. SWEEPSTAKES ENTRY:** To participate, a player must submit a \$5 non-winning Virginia Lottery MUSCLE CAR MONEY scratcher ticket via an established entry method for this Sweepstakes. Entries for this Sweepstakes will be accepted via U. S. mail, the internet and text message.
- D. ENTRY DEADLINE:** All mailed Sweepstakes entries must be received at the Lottery Contest P.O. Box # 1758 by Monday, June 14, 2010 in order to be eligible to participate in the Tuesday, June 15, 2010 drawing, by Monday, July 19, 2010 in order to be eligible to participate in the Tuesday, July 20, 2010 drawing, by Monday, August 23, 2010 in order to be eligible to participate in the Friday, August 27, 2010 drawing and entries received by Monday, September 27, 2010 in order to be eligible to participate in the Tuesday, September 28, 2010 drawing. Internet and Text entries will be accepted until 11:59 p.m. on Monday, June 14, 2010, until 11:59 p.m. on Monday, July 19, 2010, will be accepted until 11:59 p.m. on Monday, August 23, 2010 and until 11:59 p.m. on Monday, September 27, 2010. Entries not selected to win a prize in a drawing will not be eligible for the subsequent drawings.

E. MAILED ENTRIES:

1. To enter by mail, a player must **clearly** and **legibly print** his or her full name (first, middle initial & last), birth date, street address, city, state, zip code and daytime telephone number on the back of their non-winning Virginia Lottery MUSCLE CAR MONEY scratcher ticket submitted as their Sweepstakes entry (An address stamp or self-addressed label may be used). The non-winning ticket must be mailed in an envelope no larger than 4½” x 9 ½” during the Sweepstakes Period, to the Sweepstakes address:

Entries will not be accepted that are mailed to or delivered to any other Virginia Lottery address.

2. Only one (1) name may be recorded on a non-winning ticket. In the event that more than one (1) name is recorded on a ticket, the first name shall be deemed to be, and for all purposes regarded as, the entrant.
3. Entries mailed to the Virginia Lottery with insufficient postage will be deemed invalid.
4. Mailed entries will not be opened unless the entry is selected as a winner during one of the Grand Prize drawings. Multiple entries enclosed in one (1) envelope will be disqualified.

F. INTERNET ENTRIES:

1. To enter via the Internet, a player must go to the Virginia Lottery’s contest website at www.valottery.com/muscle, access the Sweepstakes page and enter his or her full name (first, middle initial and last), birth date, street address, city, state, zip code, daytime telephone number and e-mail address. The player must follow the web page instructions for entering the validation numbers found on the back of his/her non-winning Virginia Lottery MUSCLE CAR MONEY scratcher ticket.
2. All non-winning tickets whose numbers are submitted via the Internet as a Sweepstakes Entry **must be retained**. A player will be required to submit his/her non-winning ticket to the Virginia Lottery or its designee if his/her entry is selected as a winner in the Grand Prize drawings.

3. Players must correctly enter the validation number found on the back of their non-winning scratcher ticket. The Virginia Lottery will not be responsible for validation numbers that are transposed or entered incorrectly.

G. TEXT MESSAGES ENTRIES:

1. To enter using a text message, a player must text his or her Sweepstakes Entry # from the back of any non-winning Virginia Lottery MUSCLE CAR MONEY Scratcher ticket to **82568**. Standard text messaging rates may apply.
2. All non-winning tickets whose numbers are submitted via a text message as a Sweepstakes Entry **must be retained**. A player will be required to submit their non-winning ticket to the Virginia Lottery or its designee if their entry is selected as a winner of a MUSCLE CAR MONEY Vehicle Prize or MUSCLE CAR MONEY Merchandise Prize Package drawing.
3. Players must correctly enter the Sweepstakes Entry # found on the back of their non-winning Scratcher ticket. Players that enter multiple times will need to enter their sweepstakes number found on the back of the each entry ticket. The Virginia Lottery will not be responsible for entry numbers that are transposed or entered incorrectly.

H. ELIGIBILITY:

1. Only non-winning Virginia Lottery MUSCLE CAR MONEY scratcher tickets will be accepted as valid entries for this Sweepstakes. For the purposes of this Sweepstakes, a “non-winning ticket” is defined as a ticket, purchased at a licensed Virginia Lottery retailer location or directly from the Virginia Lottery, which does not have a winning prize combination.
2. Each non-winning ticket used for this Sweepstakes must have been issued by the Virginia Lottery in an authorized manner during the Sweepstakes Period, must be intact and must not be mutilated, altered, reconstituted or tampered with in any manner.
3. This Sweepstakes is open to players eighteen (18) years of age or older. Players will be required to provide proof of their date of birth.
4. Board Members, officers, employees and vendors of the Virginia Lottery and any person(s) residing in the same household of such member, officer, employee or vendor are not eligible to participate in this Sweepstakes.

5. A player may enter the Sweepstakes more than once as long as a different non-winning MUSCLE CAR MONEY scratcher ticket is submitted with each entry. However, a player is only eligible to win one (1) prize per drawing as a result of this Sweepstakes.
6. The Virginia Lottery will not be responsible for entries submitted incorrectly or received before the Tuesday, May 11, 2010 start date or after the Monday, September 27, 2010 entry deadline date. Such entries shall be deemed invalid.
7. Only entries that are submitted in the manner described in Section E (“Mailed Entries”), Section F (“Internet Entries”) and Section G (“Text Message Entries”) of these official rules will be eligible for entry in this Sweepstakes. Hand-delivered entries will not be accepted for this Sweepstakes and will be deemed invalid.
8. Persons must correctly enter his or her personal information. The Virginia Lottery will not be responsible for information that is entered incorrectly.
9. Each entry must contain current and valid information. The Virginia Lottery will not change or update entry information for an entry that has already been submitted.
10. Prize winners who have their Winner Notification Letter returned undeliverable due to blocked e-mails or incorrect address information or expired forwarding address notifications will forfeit their opportunity to win a prize. Neither the Virginia Lottery nor its designee will be required to attempt delivery of a Winner Notification Letter more than once.
11. Virginia Lottery prizes awarded during this Sweepstakes are not transferable or assignable. Vehicle Grand Prize or Merchandise Prize Packets are not redeemable for cash.
12. Each Sweepstakes winner may be required to participate in publicity efforts. Examples include an interview with television, radio and/or newspaper reporters and/or photographers or cameramen. This information may be used in future Sweepstakes media and/or on the Virginia Lottery’s Web Page without additional consent or compensation to the winner.

I. SWEEPSTAKES DRAWING: On Tuesday, June 15, 2010, Tuesday, July 20, 2010, Friday, August 27, 2010 and Tuesday, September 28, 2010, the established drawing dates for the Virginia Lottery’s MUSCLE CAR MONEY Sweepstakes, four (4) drawings will be conducted from all eligible entries submitted via the established entry methods and by the established entry deadline date. The following is an overview of how the entries will be randomly selected for this Sweepstakes.

1. After the established entry deadline date, but prior to the drawings, all entries submitted for that drawing will be accounted for and the information loaded into a randomizer program.
2. Representatives from the Virginia Lottery's Marketing Department along with a representative from the Virginia Lottery's Security Department will oversee the use of the randomizer program to select the winning entries for this Sweepstakes.
3. The order in which the entries are drawn shall be recorded by the Virginia Lottery, and the Lottery's decision shall be final and controlling.
4. The drawings that will occur on Tuesday, June 15, 2010, Tuesday, July 20, 2010 and Friday, August 27, 2010 will include one (1) MUSCLE CAR Vehicle Prize winner and three hundred and ninety-four (394) MUSCLE CAR MONEY Merchandise Prize Packs winners.
5. The drawing that will occur on Tuesday, September 28, 2010 will include three (3) finalists to win one (1) MUSCLE CAR Vehicle Prize and three hundred and ninety-two (392) Merchandise Prize Pack winners. The finalist for the MUSCLE CAR Vehicle Prize will be eligible to participate in an on-field drawing at Virginia Tech in Blacksburg, VA in the month of October, 2010. The actual date in October will be published on the Lottery web site in the MUSCLE CAR MONEY Sweepstakes section. One (1) participant will win the MUSCLE CAR Vehicle Prize and the other two (2) participants will win \$1,000. All participants will also receive a MUSCLE CAR MONEY Merchandise Prize Pack and overnight accommodations will be provided.
6. One hundred and fifty (150) alternate entries for the Tuesday, June 15, 2010, Tuesday, July 20, 2010, Friday, August 27, 2010 and Tuesday, September 28, 2010 drawing will also be selected using the same randomizer program. All alternate entries will be recorded in the order in which they were selected, and will be used should any Prize winner be determined ineligible.
7. After the Drawing is completed, a representative of the Virginia Lottery's Security Department along with a representative of the Marketing Department will confirm that the entries selected in the drawing are valid. In the event that a selected entry is deemed invalid (see section G "Eligibility"), the first alternate with a valid entry will be selected as a winner. This process shall continue until all valid winning entries have been selected.
8. A representative of the Virginia Lottery's Security Department will confirm the drawings and officially award prizes to the winners and finalists selected.

9. Winners and Finalists for this Sweepstakes will be notified in writing or via e-mail of their winning status. Winners who fail to respond to their winner notification will forfeit their Prize.

J. MUSCLE CAR MONEY VEHICLE PRIZE DESCRIPTION: In association with this Sweepstakes, four (4) drawing will be conducted to award one (1) current model year Camaro SS, Mustang GT, Challenger R/T or Charger R/T on Tuesday, June 15, 2010, Tuesday, July 20, 2010, Friday, August 27, 2010 and Tuesday, September 28, 2010. Prize winner will have his or her choice of one (1) of the four (4) Muscle Cars vehicles. The MUSCLE CAR MONEY Sweepstakes winner will be determined in the manner described above in Section I.

K. Sweepstakes winners will be determined in the manner described above in Section I. MUSCLE CAR MONEY Merchandise Prize Packs descriptions are as follow:

Each merchandise prize pack will contain a duffel bag, key holder, sunglasses, roller cooler bag, t-shirt and cap – all with one (1) of the following car logos: Mustang, Camaro®, Challenger or Charger – winner’s choice.

L. WINNER PROCEDURES:

1. The MUSCLE CAR MONEY Vehicle Prize Winners selected in association with this Sweepstakes will each be notified by an official letter sent by the Virginia Lottery. Included with the congratulatory letter will be a Claim form, an Affidavit of Eligibility form, a pre-paid, pre-addressed UPS return envelope and a complete copy of the Virginia Lottery’s MUSCLECAR MONEY Official Sweepstakes Rules.
2. Each MUSCLE CAR MONEY Vehicle Prize Winner will be required to complete the forms included in his or her information packet and return all completed forms in the prepaid, pre-addressed UPS envelope by the deadline date stated in each congratulatory letter.

M. TAXES:

1. All prize winners for this Sweepstakes will be provided with a 1099 tax statement for tax reporting purposes if their prize exceeds \$600.
2. The Virginia Lottery or its designee will pay the state and federal withholding tax on the winner’s behalf for the vehicle prize. Each winner will be responsible for any additional taxes owed as a result of winning a prize in this Sweepstakes.

N. APPLICABILITY OF OTHER RULES: The rules and procedures set forth in these Virginia Lottery MUSCLE CAR MONEY Official Sweepstakes Rules shall govern this Sweepstakes, except where the same are in conflict with more specific applicable laws, rules or regulations, in which case the more specific applicable laws, rules or regulations shall control.

- O. CANCELLATION OF SALES, DRAWING OR PRIZE AWARDS:** The Virginia Lottery's Executive Director may, in the Executive Director's sole discretion, cancel drawings on holidays, days of special importance or on days when conditions make conducting the drawings impractical or inappropriate, and may elect to conduct drawings and make-up drawings at such times and dates, and pursuant to such methods, as the Executive Director may determine, all in the Executive Director's sole discretion. Neither the Virginia Lottery, the Executive Director, nor any employee of the Virginia Lottery or member of the Virginia Lottery Board shall have any liability whatever for any such termination.
- P. TERMINATION OF SWEEPSTAKES:** The Virginia Lottery's Executive Director may, at anytime, announce a suspension or termination of the Virginia Lottery MUSCLE CAR MONEY Sweepstakes, without advance notice and in the Executive Director's sole discretion, at which point no further entries will be accepted and no additional Prizes shall be awarded. Neither the Virginia Lottery, the Executive Director, nor any employee of the Virginia Lottery or member of the Virginia Lottery Board shall have any liability whatever for any such termination.
- Q. GOVERNING LAW:** By participating in the Virginia Lottery MUSCLE CAR MONEY Sweepstakes each person agrees to comply with and abide by the Virginia State Lottery Law, all Rules and Regulations of the Virginia Lottery, all final decisions of the Executive Director of the Virginia Lottery, and all rules, policies and procedures established by the Virginia Lottery Board and/or Executive Director of the Virginia Lottery for the conduct of this Sweepstakes. Any dispute arising which relates to any aspect of this Sweepstakes shall be governed by the laws of the Commonwealth of Virginia and the venue for the determination of any such dispute shall be in the city of Richmond, Virginia.
- R. WAIVER OF CLAIMS:** By entering this Virginia Lottery MUSCLE CAR MONEY Sweepstakes, all Sweepstakes winners agree to indemnify, hold harmless, and waive any claims against, the Virginia Lottery, and any of the affiliates, employees, directors, officers, agents, representatives and assigns of any of said entities, arising, directly or indirectly, out of, or in any way connected with, this Sweepstakes or the prizes awarded in connection therewith.
