



DIRECTOR'S ORDER NUMBER FOURTEEN (2023)

VIRGINIA LOTTERY'S "LIVIN' LUCKY WITH LUKE COMBS" PLAYER PROMOTION FINAL RULES FOR OPERATION.

The Virginia Lottery's "**Livin' Lucky with Luke Combs Player Promotion Rules**" are promulgated in accordance with §§2.2-4002B(15) and 58.1-4006A of the *Code of Virginia* to introduce players to and encourage trial of the Luke Combs Instant and Scratchier games. The Promotion opens on February 7, 2023, contains three (3) Entry Periods, three (3) Prize Drawings, and closes on May 7, 2023, with the Promotion's final Prize Drawing on or about May 9, 2023. These rules amplify and conform to the duly adopted Virginia Lottery regulations for the conduct of Lottery games.

This Director's Order becomes effective on February 7, 2023, and shall remain in full force and effect through the end Promotion date unless amended or rescinded by further Director's Order.

VIRGINIA LOTTERY'S LIVIN' LUCKY WITH LUKE COMBS' PLAYER PROMOTION OFFICIAL RULES

- A. PURPOSE:** A Promotion will be conducted to introduce players to and encourage trial of the Luke Combs Instant and Scratcher games. With this Promotion, three (3) Prize Drawings will be conducted to award **Livin' Lucky with Luke Combs VIP Experience** Trips to see country artist Luke Combs in concert and a chance to win \$10,000 and \$500,000. One trip prize winner will be selected from all Virginia Lottery trip prize winners to win \$10,000. In addition, all trip prize winners from all participating Lottery jurisdictions will be part of a drawing for a chance to win \$500,000.
- B. PROMOTION PERIOD:** This Promotion will run from February 7, 2023, through May 7, 2023, ("Promotion Period"), with the final Prize Drawing on or about May 9, 2023.
- C. DEFINITIONS** (for purposes of this Promotion):

"Account" means the Virginia Lottery account through which a Player's age and identity verification takes place.

"Cash Prize" means a monetary Prize or a gift-card Prize.

"Claimant" means a verified Entrant, Participant, or Player who presents an Entry that he/she presumes to be a Winning Entry.

"Computer-generated Game" means a Virginia Lottery Game in direct communication with a Mainframe computer operated by or at the direction of the Virginia Lottery.

"Director" means the Executive Director of the Virginia Lottery as established in Chapter 40 of Title 58.1 (§58.1-4000 *et seq.*) of the *Code of Virginia* or any other employee(s) to whom the Executive Director's authority is lawfully delegated.

"Drawing" means a formal process of randomly selecting Entries in accordance with the Promotion Rules.

"Entrant," "Participant," or "Player" means a Person who is at least eighteen (18) years of age who makes a qualifying purchase or otherwise validly enters a Promotion according to the approved Entry method(s) stated in the Promotion Rules in the hope of winning a Prize.

"Entry" means a method, whether electronic or paper-based, by which a Player enters a Drawing or Promotion.

"Entry" or "Entry Form" means a method, whether electronic or paper-based, by which a Player enters a Drawing or Promotion.

"Entry Period(s)" means the time frame(s) during which Entries for this Promotion will be accepted.

"eXTRA Chances Web Code" means a series of numbers and letters that, when submitted according to

any of the applicable Entry methods described herein, and when used in conjunction with all other required entry data, enters a Player into the eXTRA Chances Promotion.

"Instant Game" means a digital Lottery Game with self-contained play area(s), legend(s), symbols, numbers, and/or code(s) that, when played, immediately reveals or informs the Player of the Game outcome.

"Lottery" means the Virginia Lottery.

"Lottery Board" means the group of seven (7) people, appointed by the Governor of Virginia, with the power to adopt regulations governing the establishment and operation of the Virginia Lottery and to perform other functions that are set out in the *Code of Virginia*.

"Lottery Retailer," "Lottery Sales Retailer," or "Retailer" means a Person licensed by the Virginia Lottery to sell and dispense Virginia Lottery products.

"Mobile Application" or "Mobile App" means a software application developed specifically for use on small, wireless computing devices, such as smartphones and tablets, rather than desktop or laptop computers, via which certain Promotion Entries may be submitted.

"Noncash Prize" means a merchandise or experiential Prize, such as a vehicle, trip, concert tickets, etc.

"Person" means a natural person and may not extend to or be applied to a corporation, company, partnership, association or other entity, or when referring to a Lottery retailer, the term as defined in § 58.1-4009 of the *Code of Virginia*.

"Prize" or "Prizes" means the winnings as defined in **Section K** ("Prize Description").

"Prizewinner" means a verified Person who is entitled, via Entry verification, to receive a Prize under the rules of a Promotion.

"Promotion" means the "added value" offer to consumers named in the title at the top of Page 1 of these Rules.

"Promotion Entry Number" means the 14-digit number printed on the back of a Scratcher that, when submitted according to any of the applicable participation methods described herein, and, when used in conjunction with all other required Entry data, enters a Player into a Promotion.

"Promotion Rules" or "Rules" means these rules.

"Scratcher" means a ticket with a coating over the Play Areas that, when scratched off, reveals instant game play results.

"Scratch Game" means a game, played via Scratcher, that contains the appropriate Play Areas, Legend(s), Barcodes and other codes that, when played, reveals or informs a Player immediately whether he/she has won a Prize as specified in the Game Rules.

"Self-service Vending Machine" or "Vending Machine" means an interactive device by which a Player may select a game, purchase a Ticket, and/or receive a Promotion Entry Form, without the help of a clerk at a Virginia Lottery Retailer or an employee at a Virginia Lottery office or other approved location.

"Ticket" means a Ticket produced by the Virginia Lottery's gaming system and sold by the Virginia Lottery.

"Web Code" means the 6-digit code printed on the front of a Scratcher that, when submitted according

to any of the applicable participation methods described herein, and when used in conjunction with all other required Entry data, enters a Player into a Promotion.

“Winning Entry” means an eligible Promotion Entry, drawn during an established Prize Drawing, that has passed all Lottery validation and security requirements and processes.

D. ELIGIBILITY:

1. This Promotion is open to Players eighteen (18) years of age* or older. A Player will be required to provide proof of his/her date of birth.

*Although the minimum age of a Prizewinner is 18, **any Prizewinner under the age of 21 must be accompanied on their VIP Experience trip by an adult 21 years of age or older. The primary person booking the room must be 21 years of age. State laws prohibit persons under the age of 21 from gambling and/or drinking. No exceptions.**

2. Persons who are in the voluntary exclusion program, pursuant to §58.1-4015.1 of the *Code of Virginia*, are ineligible to participate in any Lottery promotions.
3. No officer, employee or Board member of the Lottery, or any officer or employee or board member of any vendor to the Lottery of Computer-generated or Scratch Game goods or services working directly on a contract with the Lottery for such goods or services, or any person residing in the same household of any such Board member, officer or employee, or any person under the age of eighteen (18) years, shall be eligible to participate in this Promotion. The Lottery will not award a Prize on an Entry submitted by, for, or gifted to or transferred to anyone referenced under this **Section D**, or to the transferee of such Person.
4. No officer or employee of **Atlas Experiences, LLC** shall be eligible to participate and win a Prize in this Promotion.

E. PROMOTION ENTRY: To participate, a Player must purchase a Virginia Lottery five-dollar (\$5) **Livin' Lucky with Luke Combs** Scratch Ticket or play any price point of the Livin' Lucky with Luke Combs online instant game during an Entry Period specified in **Section J** (“Entry Deadlines”). Both winning and non winning Livin' Lucky with Luke Combs Scratch Tickets and online instant game entries will be accepted for this Promotion. Entries for this Promotion will be accepted via the Promotion's landing page on the Lottery's website, the Lottery's mobile app, and/or online instant game entries.

Players entering an eligible five-dollar (\$5) **Livin' Lucky with Luke Combs** Scratch Ticket also will be eligible to use the Scratch Ticket as an Entry in the Virginia Lottery's flagship Scratch Ticket 2nd Chance program, *eXTRA Chances Promotion*. Although both winning and nonwinning **Livin' Lucky with Luke Combs** Scratch Tickets are eligible for entry into this Promotion, only **nonwinning Livin' Lucky with Luke Combs** Scratch Tickets are eligible for entry into the *eXTRA Chances Promotion*. **Livin' Lucky with Luke Combs** Scratch Ticket Entries used to enter into the *eXTRA Chances Promotion* must be done separately. Entering the Scratch Ticket into the **Livin' Lucky with Luke Combs** Promotion does not automatically enter the ticket into the *eXTRA Chances Promotion*. Each nonwinning **Livin' Lucky with Luke Combs** Scratch Ticket entered into *eXTRA Chances* is worth five (5) *eXTRA Chances* entries.

Entries for both the Livin' Lucky with Luke Combs and eXTRA Chances Promotions are eligible for one (1) Prize Drawing per Promotion and will not carry over to subsequent Prize Drawings. Players are eligible to win a Prize in each Promotion subject to compliance with Scratcher Ticket Entry requirements as specified above.

All Entries submitted according to **Section G** ("Website Entries"), **Section H** ("Mobile App Entries") and **Section I** ("Online Instant Game Entries") received during the Promotion Entry Periods as specified in **Section J** ("Entry Deadlines"), will be included in the applicable Prize Drawings established for this Promotion.

Entries for this Promotion will only be eligible for one (1) applicable **Livin' Lucky with Luke Combs** Promotion Prize Drawing. The entries do not carry over to subsequent Prize Drawings. Each Entry must contain unique entry information that will be necessary to enter this Promotion. Unique entry information can only be used once for Entry into the appropriate Prize Drawing.

The **Livin' Lucky with Luke Combs** online instant game entries are only eligible for entry into this Promotion. These entries will not be eligible for entry into an eXTRA Chances Prize Drawing.

F. ENTRY REQUIREMENTS:

1. Only **Livin' Lucky with Luke Combs Scratchers (Game #2194)** or **Livin' Lucky with Luke Combs** online instant game plays purchased from the Virginia Lottery during the Promotion Period detailed in **Section B** will be accepted as valid Entries for this Promotion.
2. Each **Livin' Lucky with Luke Combs Scratcher (Game #2194)** or **Livin' Lucky with Luke Combs** online instant game play used for this Promotion must have been issued by the Lottery in an authorized manner and submitted during one of the Entry Periods referenced in **Section J** ("Entry Deadlines").
3. A Player may submit to *this* Promotion, a maximum of twenty-five (25) eligible Scratcher Entries per day over the course of the Promotion. This requirement does not limit a Player from entering into other Promotions being offered simultaneously. There is no limit for online instant game entries submitted for this Promotion.
4. Players who enter using an eligible Scratcher will earn ten (10) entries into this Promotion. For every \$0.50 played for the eligible online instant game, the Players will qualify for one entry into this Promotion. *Free online instant bonus games are not eligible for entries into this Promotion.*
5. A Player will be eligible to win **one (1) Prize during this Promotion**. Once a Prizewinner has won a Prize in a Drawing, he/she will **not** be eligible to win again in another Drawing for this Promotion. Refer to **Section E** ("Promotion Entry"). Entries that are not selected as a Prizewinner in a Prize Drawing **do not** carry over to subsequent Prize Drawings.
6. The Lottery will not be responsible for **Livin' Lucky with Luke Combs** Scratchers and online instant game entries submitted incorrectly or received outside of the established Entry Periods for the Prize Drawings) as specified in **Section J** ("Entry Deadlines"). Such Entries shall be deemed invalid.
7. Only Entries that are submitted in the manner described in **Section G** ("Website Entries"), **Section H** ("Mobile App Entries"), and **Section I** ("Online Instant Game Entries") of these Promotion Rules during the designated Entry Periods will be eligible for Entry in this Promotion and to win a Prize. Hand-delivered Entries and Entries submitted via any other methods not specified in these Promotion Rules will not be accepted as an Entry for this Promotion and will be deemed invalid.

8. Each Entry submitted for this Promotion must contain the Entrant's current and valid information in order to be eligible to win a Prize in this Promotion. The Lottery will not change or update information for an Entry that has already been submitted. This includes address and telephone number updates. The Lottery will not be responsible for numbers that are transposed or for information that is entered incorrectly. The Lottery will not be responsible for data-entry errors by Entrants or for connectivity issues involving the Player's access to the Virginia Lottery's Website or Mobile App.
9. Each applicable Scratcher or online Instant game entry used for this Promotion must have been issued by the Lottery in an authorized manner during the Entry Periods referenced in these Rules, must be intact and must not be mutilated, altered, reconstituted and/or tampered with in any manner.
10. A Prizewinner's *Winner Notification Letter* will be mailed to the address registered with the Winner's Player Account at the time of his/her Entry submission. Any Prizewinner whose *Winner Notification Letter* is returned or is undeliverable due to incorrect and/or incomplete address information, expired forwarding address notifications and/or delivery delays due to mail forwarding notifications, and the Prizewinner fails to notify the Lottery **prior to the claim deadline date** regarding the incorrect address, will forfeit his/her opportunity to win a Prize in this Promotion. Neither the Lottery nor its designee will be required to attempt delivery of a *Winner Notification Letter* more than once unless the Prizewinner notifies the Lottery **prior to the claim deadline date** regarding the incorrect address. If the Lottery is notified prior to the claim deadline date, the Lottery will email the required form(s) to the Prizewinner using the email address registered with the Winner's player account at the time of their Entry submission.
11. Only Web Codes and Promotion Entry Numbers printed on eligible **Livin' Lucky with Luke Combs** Scratchers entered in the manner described in **Section G** ("Website Entries") or **Section H** ("Mobile App Entries") or entry information supplied from an eligible **Livin' Lucky with Luke Combs** online instant game purchase and entered in the manner described in **Section I** ("Online Instant Game Entries") will be eligible for Entry into this Promotion.

G. WEBSITE ENTRIES:

1. To enter, a Player must go to the Lottery's Promotion's landing page at www.valottery.com/livinlucky and successfully complete registration* or login.

*Registration will require entry of a Player's correct full name (consisting of his/her first name and last name – no initials), date of birth, street address, city, state, ZIP code, last four (4) digits of his/her Social Security Number, and telephone number.

2. As part of the Lottery's registration process for this Promotion, third-party identity authentication will confirm that the Player is eighteen (18) years of age or older. If a Player's identity cannot be confirmed, additional steps for manual confirmation of identity will be provided.
3. Players entering via the Internet can use a computer, mobile device, and/or a mobile telephone to access the Lottery's Website. When using a mobile telephone, a Player can choose to enter their Luke Combs Scratcher Ticket information manually or enter by using their mobile telephone's camera to scan the Ticket Number Barcode listed on the eligible Scratcher.

4. Players who choose to manually enter their Web Code and Promotion Entry Number must correctly enter **BOTH** the Promotion Entry Number found on the back of each eligible **Livin' Lucky with Luke Combs** Scratcher and the Web Code found on the front of each eligible **Livin' Lucky with Luke Combs** Scratcher. The Lottery will not be responsible for numbers that are transposed or entered incorrectly. If the numbers cannot be verified, the Entry will be deemed invalid and not eligible for entry into this Promotion.
5. Once a Player has successfully entered his/her **Livin' Lucky with Luke Combs** Scratcher Ticket information via the Lottery's Website, the Player **does not** need to retain their Scratcher Ticket in order to claim a Prize in this Promotion or an eXTRA Chances Prize Drawing.

H. MOBILE APP ENTRIES:

1. To enter via the Lottery's Mobile App, a Player must have the app downloaded on their mobile device and then go to the Promotions tab and select the **Livin' Lucky with Luke Combs** Promotion where the Player must tap on the "Scan To Enter" button and successfully complete registration* or login if already registered.

*Registration will require entry of a Player's correct full name (consisting of his/her first name and last name – no initials), date of birth, street address, city, state, ZIP code, last four (4) digits of his/her Social Security Number, and telephone number.

2. As part of the Lottery's registration process for this Promotion, third-party identity authentication will confirm that the Player is eighteen (18) years of age or older. If a Player's identity cannot be confirmed, additional steps for manual confirmation of identity will be provided.
3. Players must correctly scan and enter their **Livin' Lucky with Luke Combs** Scratcher Ticket Number Barcode to enter this Promotion. Entries whose Luke Combs Scratcher information cannot be verified will be deemed invalid and not eligible for entry into this Promotion.
4. Once successfully entered via the Mobile App, Players **do not** need to retain their Scratcher(s) in order to claim a Prize.

I. ONLINE INSTANT ENTRIES:

1. To enter based upon the purchase of a **Livin' Lucky with Luke Combs** online instant game, a Player must have an online player wallet set up to allow the Player to purchase and play specified Virginia Lottery games via the Internet.

For every 50 cents played of the **Livin' Lucky with Luke Combs** online instant game between February 7, 2023 and April 30, 2023, a player will qualify for one entry. The player will receive an email the day after the purchase to redeem the entry. The **entry date** for an online instant game entry is determined by the date on which the entry is redeemed by email for the applicable drawing. *However, free bonus games are not eligible for entries into the promotion.*

2. Players must click the "Submit My Entry" button included in their email notification to enter this Promotion. Entries submitted will appear in the Player's account under "Chance to Win."

- All Prizewinners with this Promotion and winners from other participating Lottery jurisdictions will be included in a random multi-state drawing for a chance to win \$500,000* to be announced and awarded by Luke Combs at his concert performance

***Applicable minimum state and federal taxes will be paid on a Prizewinner's behalf for additional Cash Prizes awarded as a result of secondary Prize Drawings in association with this Promotion.**

L. PROMOTION DRAWINGS: The following are the three (3) established Prize Drawing dates for this Promotion.

Drawings will be conducted from all eligible Entries submitted via the established Entry methods and by the established Entry deadline dates. The following is an overview of how the Entries will be randomly selected for this Promotion.

1. After the established Entry deadline date, but prior to each Drawing, all eligible Entries submitted for that Drawing will be accounted for and the information loaded into a randomizer program.
2. Representatives from the Lottery's Security, Marketing, and Information Technology Services departments will oversee the use of the randomizer program to select the Winning Entries for this Promotion.
3. Winning Entries will be randomly selected for each Drawing. The order in which the Winning Entries

are drawn shall be recorded by Lottery officials. The Lottery's decision shall be final and controlling.

4. Immediately after the Prizewinners are selected for each Drawing, ten (10) alternate Entries also will be selected using the same randomizer program. All alternate Prizewinners will be recorded in the order in which they were selected and will be used at the Lottery's discretion should any Prizewinner be determined ineligible.
5. After each Prize Drawing is completed, representatives of the Lottery's Security, Marketing, and Information Technology Services departments will confirm that the Entries selected in that Drawing are valid.
6. In the event that a selected Entry is deemed invalid (see **Section F** "Entry Requirements"), the first alternate with a valid Entry will be selected as a Prizewinner. This process shall continue until all valid Winning Entries have been selected for the particular Prize.

M. PRIZEWINNER PROCEDURES:

Each Promotion Prizewinner selected in association with this Promotion will be notified by the Lottery via the United States Postal Service (USPS). All Prizewinners will receive a *Prizewinner Claim Form* and a *Promotion Prize Waiver and Release Form*. The Prizewinner will be required to complete and return both forms and any additional applicable forms (by the deadline stated in his/her *Winner Notification Letter*. Any Prizewinner who fails to fully complete and return both of the required forms (as applicable to the Prize) with his/her *Winner Notification Letter* along with documentation containing his/her full Social Security number (if required by the specific claim form) by the date noted in his/her *Winner Notification Letter* will forfeit his/her Prize.

N. PRIZEWINNER RESPONSIBILITIES:

Each Prizewinner who wins a Prize involving travel and/or an event where alcohol is served understands that failure to adhere to the following, as applicable, will result in the forfeiture of his/her Prize:

1. The Virginia Lottery, and/or the Lottery's vendor personnel or their designee, reserve the right to revoke full or partial components of a Prize from a Prizewinner or his/her guest if either is deemed intoxicated, a safety risk, or has violated any law and/or hotel, airline and/or event policy.
2. To board an airplane or check into a hotel, a valid state-issued photo ID is required.
3. Airlines reserve the right to charge for baggage. If applicable, the Prizewinner and his/her guest will be responsible for these charges.
