



## **DIRECTOR'S ORDER NUMBER SIXTY (60 2023)**

CERTAIN VIRGINIA LOTTERY COMPUTER GENERATED GAME; CHANGE TO CUT-OFF TIME TO MAKE ONLINE PLAY PURCHASES

This Order is issued in accordance with §§ 2.2-4002B (15) and 58.1-4006A of the Code of Virginia. Notice is hereby given that the following Virginia Lottery Computer Generated Game:

### **POWERBALL® (26 2023)**

is amended as follows in order to modify the purchasing cut-off time for online play purchases:  
in **Section B: Definitions**

From:

“**Powerball**® Cut-off” or “Imminent” means the time after which Lottery Plays will not be accepted for that Drawing. The Imminent occurs on Mondays, Wednesdays, and Saturdays at 10:00 PM Eastern Time for each **Powerball**® Drawing.”

To:

“**Powerball**® Cut-off” or “Imminent” means the time after which Lottery Plays will not be accepted for that Drawing. The Imminent for each **Powerball**® Drawing occurs on Mondays, Wednesdays, and Saturdays at approximately 10:00 PM Eastern Time for Game sales at retail locations and approximately 9:58 PM Eastern Time for online play sales.”

in **Section F: How To Play:**

**From:**

5. “Cut-off of Play: Plays for a particular Drawing will be accepted by the computer system until approximately 10:00 PM Eastern Time on the day of that Drawing.”

**To:**

5. “Cut-off of Play: Plays for a particular Drawing will be accepted by the computer system until approximately 10:00 PM Eastern Time for Game sales at retail locations and approximately 9:58PM Eastern Time for online play sales, on the day of that Drawing.”

With the exception of the foregoing changes, all terms, conditions, and requirements of the original order and the original game rules continue to apply and remain in full force and effect.
